### **DBS: Three-year reminder**

We would like to remind you of the changes in the Safer Recruitment and People Management policy relating to the frequency of DBS checks.

- Currently dioceses complete renewal checks once every five years, but this is changing to once every three years.
- Dioceses have until January 2024 to make sure all DBS certificates are within a three-year period.
- In this diocese we have decided to make the changes in stages and starting from 1 June 2022
- Any new DBS applications will be on an automatic three-year renewal cycle.

#### **Due Diligence Checking**

Karen is working with Due Diligence Checking to find a way to identify existing certificates which will need to be renewed by January 2024 to be within the three-year period. You may receive a list of names. If your list includes members of Clergy, Lay Elders, Readers, or anyone with a licence or commission from the Bishop, please let Sally know because she will need to request these checks. This will avoid unnecessary doubling up of applications.

#### **Document Checkers**

There is some confusion around document checkers and the accounts for which they can check documents. Sally has her own document checkers, registered on her account, who can check the documents for the applications she puts through, such as checks for Lay Elders and Readers. People registered as document checkers on local accounts are not automatically registered on Sally's account. Sally's applicants can only choose document checkers registered on Sally's account. They will find the list of names on the drop-down list as they fill in the details on their application.

#### **Verification of Documents**

The rules have also changed regarding verification of documents. Covid restrictions permitted this, via video link, but at the end of September 2022 this permission was withdrawn. Going forward all document checks must be completed in person with sight of hard copies of all documents.

#### Santa

At this time of year, we are often asked "does our Christmas Fair Santa need a DBS check?" The answer is **no**. A visit to Santa does not meet the criteria for a regulated activity as it is a one-off event. Parents are also usually in attendance. The completion of a Confidential Declaration Form can be requested, but not an Enhanced DBS check.



#### **Training**

We have reviewed our process for booking training. Going forward, the following Zoom and in person training courses will need to be booked via Eventbrite:

- Basic Awareness
- Foundation
- Leadership

Booking for courses starting in January 2023 will be open in December.



- Basic Awareness
- Foundation
- Domestic Abuse
- Safer Recruitment

Please can we ask you to remind people that the Leadership Course takes several weeks to complete as currently we have people booking onto a course just days before they need their certificate. This course involves:

- pre-work
- two group discussion sessions (that are usually a week apart)
- · two to six weeks of reflection

Only after all these stages have been completed are certificates issued, so please do encourage those who need to complete this training not to leave it until the last minute.

We understand that there are last minute unavoidable circumstances which prevent people attending a training event. Recently we have had several people pull out of events at the last minute for reasons they have been aware of for some time. We would ask that people give as much notice as possible if they are not able to attend. This enables us to offer the place to someone else and make full use of our training resources.

We are still encouraging people who have not used the Safeguarding Dashboard to try it! Currently 50% of parishes are actively using the tool and feedback received has been positive. There are three levels to work through and you can do so at your own pace. ## Past Case Review 2 (PCR2)



Following the publication of the National Church's report on 5 October 2022, we issued a redacted version of the diocesan findings onto the diocesan website. The redactions have been made to prevent identification of individuals. The diocese has accepted all the recommendations made by our Independent Reviewers and has already started to address them. The Diocesan Safeguarding Team will also be working with the National Safeguarding Team to address the recommendations in the national report.
